# ASSESSMENT OF THE USE OF INDIGENOUS LANGUAGES AND ENGLISH AS MEDIUMS OF INSTRUCTION IN LOWER AND MIDDLE BASIC EDUCATION CLASSROOMS OF KADUNA STATE NIGERIA

# Abstract

It is noteworthy that mother tongues and the English language enjoy great recognition in Nigeria. They perform various functions in formal and informal contexts of multilingual Nigerian communities. Apart from being adopted as national and official languages, their functions have been expanded for the teaching and learning purposes in Nigerian basic education schools. Both mother tongues (national languages) and the English language have syllabuses at basic education levels such as lower basic, which includes primary one to three and middle basic which deals with primary four to six. There have been growing debates on the best language needed for teaching children in basic education for long. This was what led to the consensus that instructions in early basic education classrooms in especially multilingual contexts need to start in the language of the child since every human child has a language he/she comes in contact with before schooling. In line with this, this article is written to look into the factors and issues surrounding the use of mother tongue in early years of basic education and of course to the use of the English language in later years as languages of instructions. Both mother tongues and English have syllabuses designed to guide teachers on what to teach, the period of teaching, teaching objectives, contents of learning experiences and activities in lower and middle basic education. It is believed that both mother tongue and English language syllabuses are by their nature, expected to give the leaner a gradual learning process which fosters progressive as well as comprehensive understanding of the aspects of both the native and the target language for effective instructions in basic education classrooms in Kaduna state, Nigeria. The paper recommends the employment of innovative teachers of mother tongue and English who have encyclopedic understanding of the complexities associated with the first and second language teaching and learning, use of harmonized syllabuses, good libraries, good textbooks and a variety of methods for effective teaching and learning.

# Introduction

Language is an instrument that facilitates and promotes societal coexistence. No one can water down the fact that people cannot exist without language. Using both the mother tongue and English language effectively from basic education level is an indication that languagepolicy provisions are practically implemented from basic education level. Good foundation in the use of mother tongue for instruction provides the ground for the English language teaching among learners at middle basic education level for the development of literacy, reading and other language skills in the basic educational system through the mother tongue in lower basic education; primary 1 to 3.

A good language policy makes knowledge and skills accessible to the child, adaptable to his socio-cultural, socio-political and socioeconomic environment and of course proper upbringing for the development of the human child mentally, physically, academically and morally. After the development and introduction of a new language policy in education from the year 2013 in Nigeria, there is the need for assessing use of the mother tongue and English as mediums of instructions to identify if implementation of the provisions of language policy has provided the much needed literacy and reading skills to children in

both mother tongue and English.

The objectives of carrying out this study were to:

- 1- Assess how language policy provisions are implemented through the use of mother tongue and English in Kaduna State Universal Basic Education schools:
- 2- Investigate if the needed atmosphere provided for helping teachers carry out instructions at the point of switch from mother tongue to English language medium of instruction in Kaduna State Universal Basic Education Schools:
- 3- Determine the practical challenges debilitating against the use of mother tongue and English language as mediums of instruction in Kaduna State Universal Basic Education Schools:

# **Research Questions for the Study**

The provided answers to the following research questions:

- 1- What is the extent to which language policy provisions are implemented through the use of mother tongue in Kaduna State Universal Basic Education Schools?
- 2- What is atmosphere provided in helping teachers carry out instructions at the point of switch from mother tongue to English language medium of instruction in Kaduna state universal basic education schools?
- 3- What are practical challenges debilitating against the use of mother tongue and English as mediums of instruction in Kaduna State Universal Basic Education Schools?

# **Research Methodology**

For carrying out this study, three hundred and eighty-two (382) teachers consisting both male and female were sampled from the population of 22,435 of primary school teachers in Kaduna state. About fifty percent of the teachers are specialists in child mother tongue(s) and other are those that specialize in English. The sample of the study was drawn across three senatorial districts: Kaduna south, Kaduna central and Kaduna north senatorial districts from the year 2017, 2018, to the year 2019. The Four-point Likert scale research questionnaire was developed by the researchers. The results obtained were analyzed using the statistical instruments of mean and standard deviation. The research questionnaire was developed by the researchers and was validated by four experts in the field. The Cronbach Alpha was used in determining a reliability coefficient of 0.83.of the research questionnaire. Mean scores and standard deviation were used by the researcher to answer the research questions. For the conduct of this study, the discussions in this section provides answers to research question one, while responses of the teachers to the questionnaire provide answers to research question two. A number of practical challenges associated with switch from mother tongue to English were given as answers to research question three.

# **Theoretical Framework**

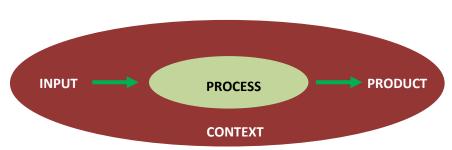
In this research, the theoretical framework considered appropriate for the accomplishment of the objectives of the study is the Context Input Process Product (CIPP) initiated by Daniel Stufflebeam as revised by Mathew (2014). The Context Input Process Product (CIPP) approach is outstanding among the various theories used for the assessment of the public project, policies and programmes of various countries to assess their level of growth and decay with respects to the main objectives for which the public projects or policies are established. Rogers (2014) believes that the American scholar, Stufflebeam in 1966, invented the CIPP model. The major components of the theory are as follows:

- A. Evaluating the context in which the policy or project is executed. This includes considering the effect of other policies or projects (as evident in other countries' language policies for determining aspects of language policy implementation that could be adopted in Nigeria), and the budget specifically made for implementation in Nigeria);
- B. Evaluating the input into the project is by looking at the information (such as needed facilities for the language needs of the learner) the decisions made for the teaching of basic education children in their languages of origin;

- C. Evaluating the product, that is the expected results of language-policy implementation project (such as developing the literacy and reading ability of the UBE pupils, accelerating their communicative competence and performance, understanding their culture and environment, as well as technical concepts in science-based subjects;
- D. Utilizing the information gained from the context, input and product evaluation of the language-policy implementation project. The purpose of this is to determine what can be done to improve the success of the policy or project. Below is the graphic representation of the CIPP model.



# Objectives of Universal Basic Education in Nigeria

As a way of demonstrating the intention of the federal and state governments of Nigeria for providing universal access to quality basic education in the country, the current edition of National Policy of Education published in 2013 cancels the six-year final examinations across the nations primary schools. The policy shows that children that have successfully graduated from primary schools will no longer take any final year examination before they are admitted into junior secondary schools across the federation. Muftau and Hazri (2015) posit that the major goals of the present UBE basic education in Nigeria are to:

- a- Inculcate reflective thinking in the mind of the Nigerian child;
- b- Make the child have the ability to pass relevant judgments;
- c- Provide the child the opportunities to acquire good communication skills;
- d- Increase productivity in the family and the larger society;
- e- Understand the role of the individual in relation to the pursuit of the national objectives, progress and development;
- f- Inculcate permanent literacy and numeracy in children and the ability to communicate effectively;

Bamgbose (1989) maintains that considering these lofty objectives that have been lined up in the UBE project, one fundamental issue that deserves consideration is the medium through which the Nigerian child can achieve these aims to make learning accessible, easy, productive, logical and practical. Anderson (2016) believes

of instruction that the language and communication must be considered to achieve those objectives. Egomwan (1991) believes that a policy is programme of action containing a series of interrelated decisions by a group of actors living in particular geographical location. In every society, including the advanced ones such those Europe and America, education has remained the major social structure for capacity building and development (Etuk, Ering and Ajake 2012:177-179). The Universal Basic Education is part of the Nigerian government's policies that are initiated in order to improve the wellbeing of the citizenry and pave the way for sustainable development in this country.

# **Basic Requirements for Switch from MT to English Medium in UBE Schools**

The Federal Republic of Nigeria (2012), shows that the 9-year basic education curriculum for English from nursery to primary school level revolves around five cardinal language areas; reading, writing, listening and speaking, grammatical accuracy and literature. Scholars such as Adams (2016:34-45) believe that African countries with multilingual education policies will succeed in providing quality basic education to their children if they start instructions in mother tongue and switch later into English medium based on some fundamental considerations. Allan (2014), Anastasi (2013) and Bachman (2009), believe that language polices flourish when mother tongue education has to cover the part or whole of the period of basic education from year 1 to 3, 4 or 6 etc. depending on the needs of learners. Allan (2014), Buck (2017), Cameron (2010) and Muftahu and Hazri (2015) believe that the

switch, however, is not supposed to haphazardly.

Brown (2016), Bygate (2013) and Buck (2017) posit that textbooks that are supposed to be used during switch into English at upper primary, must be written in impeccable English. Carpenter (2012), Carrol (2015) and Davidson (2009) explain that parts of the factors required for switch from mother tongue policy to English is the provision of functional libraries for primary, junior and secondary schools. According to Davies (2008), the e-library is currently needed in African schools to instill the culture of reading and information sharing so that students could have access to information even at home. Nitco (2017), (Davies, 2008) and Harris (2000). Davies, (2008) and Donald (2016) believe that curriculum is part of the educational programmes designed for the development of the human child in primary, junior and senior secondary school during switch from mother tongue to English will be undertaken.

Results from the Questionnaire Distributed to Teachers in Kaduna state Universal Basic Education Schools on the Use of Mother Tongue and English as Mediums of Instruction

It can be posited that after the analysis of respondents' responses as regard their gender, it is clear that 202 of the respondents are male and this represents (52.7%) of the sample regarding the male while 180 of the respondents representing (47.3%) were females. This

analysis clearly shows that the majority of the respondents to the research questionnaire were males who aired their views on their perception of the switch from mother tongue to English medium of instruction.

Looking at the table above, it is clear that the findings regarding the years of teaching experience of respondents shows that 7(1.8%) of the respondents have been between 1-4 years, 82 (21.4%) of them have been between 4-9 years, 73 (19.1%) of the respondents have been between 10-14 years, while 227 (57.7%) of the

respondents have been between 15 -19 years in their teaching. This indicates that the majority of the respondents revealed that they have been between 15-19 years of teaching studies during the periods in which data for this research was obtained.

The results above show the perception of respondents on the use of the mother tongue and English in teaching and learning in basic education in Kaduna state where primaries 1 to 3 are taught in the MT or the language of the immediate community. The findings gathered from the study revealed the cumulative mean response on all the ten (10) items asked, which was 2.69. The cumulative mean of 2.69, was found to be higher than the decision/standard mean of 2.5000. The table shows the standard deviation of 1.000, which shows that respondents are fully convinced that the use of the mother tongue in lower basic education, use of effective books, harmonized scheme of work and curriculum as well as community support are great requirements for effective switch from mother tongue to English medium of instruction.
